

# Whidbey Women + Art 2024 Benefit Art Show and Sale Artist Information

# ABOUT THE SHOW

Sponsored by <u>Soroptimist International of South Whidbey Island</u> (SISWI), the **Whidbey Women + Art Benefit Art Show and Sale** (WW+A) provides a platform to feature the work of local Washington women artists. In its fourth year, the event takes place on Whidbey Island at Dancing Fish Vineyards with over 300 people attending each day. In support of the Soroptimist goal of helping women achieve economic empowerment, the show is a marketing opportunity for artists to sell their wares and keep 100% of their sales. The Artist Participation Fee is a tax-deductible contribution for the benefit of <u>Soroptimist International of South Whidbey Island</u> (SISWI).

Soroptimist is a global volunteer organization that provides women and girls access to the education and training they need to achieve economic empowerment. Your donation helps fund scholarships, awards, and programs that support our mission.

## **ARTIST PARTICIPATION INFORMATION**

#### VENUE

- Dancing Fish Vineyards (DFV) is a family-owned winery and event venue located at: **1953 Newman Road, Freeland, WA**, on Whidbey Island, an idyllic location to host Whidbey Women + Art over Labor Day weekend.

#### **REGISTRATION & ARTIST PARTICIPATION FEE**

- Artist Participation Fee is \$150.
  - o Artist Participation Fees are for the benefit of SISWI.
  - The Artist Participation Fee is tax deductible, and you will receive a receipt from SISWI after your Artist Registration Fee and accompanying documents have been processed.
- There are no commission fees. Artists take home 100% of their sales.
- Artists are welcome to share a space with another artist. **EACH** artist is required to pay a separate Artist Participation Fee and must submit the following:
  - Completed and signed 2024 Artist Registration Form
  - Signed 2024 Artist Release and Waiver of Liability
  - Signed 2024 Artist Media Release Form
  - If you are sharing space, please indicate that artist on your registration form.

#### ARTIST RECEPTION

You are invited to an Artists' Reception at Dancing Fish Vineyards on Tuesday, August 6, 2024, from 5-7:00pm. At this reception we will assign artist display locations, finalize individual material needs, distribute event fliers, and answer questions. This is a wonderful opportunity to meet other participating artists, the Dancing Fish Team, and the Soroptimist organizers of WW+A 2024.

### SPACE ASSIGNMENT, MONEY COLLECTION & PARTICIPATION

- There are indoor and outdoor display spaces available.
- Each artist (or artists sharing a space) will be provided either a 10'X10' exterior display area or one indoor table of 6ft or 8ft. All displays must be kept within the assigned space.
  - All artists assigned an outdoor space will be provided a 10'X10' display area. Overflow of work outside the 10'X10' display area will not be permitted.
  - All artists assigned an indoor location will be provided one 8' or one 6' table and a chair.
     The available space for displaying and storing your work is dictated by the size of the table and overflow outside the table area will not be permitted.
  - o If additional space is required, an Artist may register and pay for a second display space.
- Display areas will be assigned via a lottery held during the Artists' Reception on Wednesday, August 6, 2024, at Dancing Fish Vineyards.
- If you are assigned an outdoor space, <u>you will be responsible for bringing and setting up a</u> <u>weighted canopy for shade or rain with 40lb minimum per leg</u>
- Tables, chairs, display panels, and wall space are available, <u>but in limited quantities</u>; please note your preferred material needs on your Artist Registration Form.
- Each artist is responsible for bringing tablecloth covers.
- Artists, an artist's representative, or person sharing your space must be in attendance for the
  event.
- Artists are encouraged to participate on both days. If you intend to participate only one day, you
  need to notify organizers prior to the Artists' Reception. The paid Artist Participation Fee will not
  be prorated.
- Each artist will be responsible for their own sales and method of money collection.
- Each artist will be responsible for securing their art/supplies overnight. Limited storage space will be available onsite. If possible, please take items home.
- Food is available for purchase onsite.

### ADDITIONAL DISPLAY SUPPLY/OUTSIDE RENTALS

Additional rentals (tables, canopies) are available directly from Whidbey Event Rentals. Contact Doug Bell at (360) 836-2853.

- Any direct rentals with Whidbey Event Rentals will be with the artist directly.
- Please indicate that your rental is for the Whidbey Women + Art event.
- Whidbey Event Rentals will drop off rented items on Friday, August 30, 2024, and pick up on the first business day following the show.
- Rentals are limited, please call as early as possible.

#### ARTIST SET UP & BREAK DOWN FOR THE SHOW

- Setup on Saturday begins at 7:00am. Please plan to be set up by 10:30am for customers. There are always early bird shoppers!
- Indoor set up ONLY is available Friday August 30 from 5-7pm with access behind the barn.
- The show opens to the public both days at 11:00am and closes at 5:00pm. Artists must remain set up until 5:00pm. Breaking down prior to closing provides a negative experience for both shoppers

- and surrounding artists.
- The barn will be locked on Saturday and Sunday at 6:00pm.
- Displays must be removed by 6:00pm on Sunday September 1. In order to make breakdown go as smoothly as possible, please pack up your items prior to retrieving your car.
- Unload and loading MUST be done in designated areas as directed by Soroptimist volunteers and or DFV staff.
- No nails, push pins, tape or any other implements can be used that may mar the walls or floors.
- Artists are responsible for their own lighting. Indoor spaces are in a charming lofted barn that is
  not geared to the lighting needs of art display. If your work has specific lighting needs, please
  bring appropriate display lights and extension cords (battery powered lighting is ideal!) Consider
  bringing lighting even if you don't think you need it, especially indoors. Extra lights draw attention
  to your work and attract customers.

#### **PARKING**

• For setup, artists are required to drop off their display items and then remove their cars. Onsite parking is limited and for event attendees only. If you do not have someone dropping you off/picking you up, offsite parking and shuttle service will be provided.

- 3. The Artist is responsible for the delivery, pack, transport, provide for the return of their artwork, and hanging the submitted artwork at their own risk and expense.
- 4. The Artist understands that the artwork is submitted to Soroptimist International of South Whidbey Island and exhibited at the Artist's own risk and that neither the Soroptimist International of South Whidbey Island, Dancing Fish Vineyards, nor any of its officers, agents, and employees shall be responsible for theft, vandalism, fire, or any other damages or losses to the artwork. The Artist understands and agrees that the Soroptimist International of South Whidbey Island makes no representations or warranties regarding the level of security at the Dancing Fish Vineyards facility or premises. The Artist understands and agrees that the Soroptimist International of South Whidbey Island and its officers, agents, and employees will not be responsible for reimbursement or replacement of lost, stolen, or damaged items. The Artist understands and agrees that the Soroptimist International of South Whidbey Island encourages the owner of the artwork or the owner's agent to obtain an insurance policy for the artwork or to obtain a rider on any existing policy for the duration of the exhibit.
- 5. Artist shall indemnify, save and hold harmless the Soroptimist International of South Whidbey Island and Dancing Fish Vineyards, its officers, directors, employees, volunteers and agents, and the participating artists from any and all claims, demands, causes of action and judgments, losses, costs and expenses, including but not limited to reasonable attorney's fees, arising due to the negligence of Artist, their employees, agents or other personnel hereunder, including but not limited to any representation, warranty, term and/or condition of this Agreement.
- 6. The Artist agrees that the artwork will be on display for the period August 31st, September 1st 2024.
